Disposal Voucher Process for North Richmond Mitigation Area Residents

- Submit completed Prescreening Form, photo ID and recent utility or phone bill to prove residency in the North Richmond Mitigation Area to the Prevent Service Coordinator (PSC) at CHDC Annex (1452 Fred Jackson Way, Richmond CA 94801)
- If PSC determines household is within North Richmond Mitigation Area and you submit all required information, PSC will call the phone number provided to confirm availability/disbursement of the disposal vouchers
- Contact the PSC at 510-260-0005 for questions regarding this program, depending upon the nature of your question/concern PSC may refer your call to RSS or staff from the City of Richmond/Contra Costa County.

Eligibility

- Disposal vouchers are available for a limited time, on a first come, first served basis.
- Only households located within the North Richmond Mitigation Area (map can be viewed online at www.cccrecycle.org/NRGreen) are eligible.
- Eligible households may request up to twelve (12) \$5 disposal vouchers per year.
- Residents must provide photo identification and recent phone or utility bill to prove residency at address within North Richmond Mitigation Area in order for your request to be processed.

Voucher Guidelines

- Vouchers can only be redeemed at the Golden Bear Transfer Facility (see below).
- Each voucher redeemed serves as a coupon valued at \$5 off cost of disposal (no change will be returned).
- Customers responsible for any cost in excess of the value of vouchers redeemed at the time of disposal.
- Vouchers only valid for six months and must be redeemed by expiration date.
- Only original vouchers will be accepted, do not copy or alter vouchers.
- Lost or damaged vouchers will not be replaced.
- See the reverse side of this form for additional recycling and disposal resources for various bulky items and other items allowed in curbside garbage collection program.

Redeeming Disposal Vouchers

Customers must present valid original vouchers at the time you are charged for disposal. Vouchers can only be redeemed at the following facility:

LOCAL RECYCLING & DISPOSAL RESOURCES (call first to verify acceptance and hours of operation)

Residential customers in the North Richmond Mitigation Area served by RSS are entitled to **two on-call pick-ups per year of up to fifteen (15) 30-35 gallon bags, equivalent to two cubic yards at no extra charge**.
